## **PHASES OF CALIFORNIA EVICTION LAWSUIT**

**\$1,990 Phase I UNCONTESTED Filings and Service Of**  
**Complaint, Summons Default Packets-Professionally Served**

**\$240- COURT Filing Fee-costs if over \$10K money demand then fee is \$385 or \$435**

**\$990-Attorney Fees- Retainer Will Enable Attorney To Set Aside Extra Time On Your Case**

**\$270- Attorney Service Expedited Electronic Complaint/Summons-Filings-1Legal and Click Legal**

**\$490- -PROFESSIONAL PROCESS SERVERS/ EXPEDITED E-FILINGS -Advanced Costs**

**PHASE II – CONTESTED PHASE –Trial and Motions/Preparation**  
**Trial Fee: \$2,490 if Tenant Not Represented by Attorney**

**Trial Initial Retainer For Tenants Represented By An Attorney**

**\$2,990 Retainer For Preparation (1<sup>st</sup> 3 hrs- On First Day Of Trial ).**

If Defendant Hires An Attorney Client Must Sign Hourly Fee Agreement. Thereafter Trial Fees are billed hourly at \$300/hr and \$450 week of trial + Discovery= written demands-- pre-trial evidence fee is \$990

**ALL JURY TRIALS ARE BILLED HOURLY at time of Notice**

**Oppositon To Delay Motions= \$2,490- Attorney Cases = \$2,990.**

**Extra “Ex-Parte” Hearings To Expedite Case \$499 plus \$60-court fee.**
